QUARTERLY REBALANCE NOTICE FOR THE BNC-BTSE COMPOSITE INDICES

Following approval from the BNC Index Committee, the BNC-BTSE Composite Indices will undergo their quarterly re-balance and re-constitution according to the updated constituent assets and weights found below. The indices affected are:

- BNC-BTSE Composite Index (BBCX)
- BNC-BTSE AltCoin Index (BBAX)
- BNC-BTSE Blue-Chip DeFi Index (BBDX)
- BNC-BTSE Blockchain Interoperability Index (BBIX)
- BNC-BTSE Maker Vault Index (BMVI)

Constituent assets and weights were determined on October 27th, using the average free float market capitalization of the preceding 5 days for each eligible asset. Where needed, constituent asset weights were capped based on the *weight cap* and subject to a minimum turnover requirement of 10 basis points.

This change will be implemented on **Wednesday**, **November 3**, **2021 at 08:00 am (UTC)** with no anticipated disruption.
